South Plains College Improves Each Student's Life

I. General Course Information:

A. Description: This course is an introduction to chord progressions, song forms, and harmonic techniques used in commercial music. Topics include modern chord notation and chord voicings.

Instructor's Note: This course provides a view of modern musical style with attention to the techniques by which musicians arrange the basic elements of music. Topics include key, tonality, melody, harmony, and bass. Students are guided in the use of critical thinking skills to proceed from theoretical understanding to practical employment of techniques (such as two- and three-part vocal harmonization, specific stylistic rhythm-section textures, and the construction of useful charts and sheet-music) which enhance the performance process.

B. Course Learning Outcomes: Through this course the student will become knowledgeable in:

- scales, keys, & modes
- modern chord symbols & structure, chord substitution
- melodic and accompaniment harmonizing techniques
- musical notation

C. Course Competencies: MUSC 1313 is a college level music theory course. It is not an introductory course. Students with no previous theory training should contact their advisor or the instructor to determine whether they might need a music fundamentals course (which SPC offers each semester). Many music students at SPC begin by taking MUSI 1301.

Computer-Assisted Learning –Class meetings will be Live-Streaming Video using the Collaborator platform, recorded, and posted on Blackboard. In addition to the course textbook, course content and organization will utilize the Blackboard platform. Students are expected to familiarize themselves with this software, and address any questions to the instructor in a timely manner.

D. Academic Integrity: It is the aim of the faculty of South Plains College to foster a spirit of complete honesty and a high standard of integrity. The attempt of any student to present as his or her own work which he or she has not honestly performed is regarded by the faculty and administration as a

II. Specific Course/Instructor Requirements:

A. **Textbook and Other Materials:** **Music Theory Workbook, by Chris Bowman, ISBN 978-1-4768-0852-9.** There will also be various worksheets, charts, and illustration handouts placed on the course page at Blackboard. Students are encouraged to keep thorough notes of class lectures, diagrams, examples, and exercises. Students have on hand music manuscript paper, conventional notebook paper, pen, and pencil for each class session.

Attendance Policy:

Students are required to attend the streaming video lectures at the regularly scheduled times.

Good attendance is critical in the world of work. It is the cornerstone of academic success. For these reasons, attendance is a grade in this class. For each unexcused absence, 3 points will be subtracted from the overall average. Tardiness may result in 1 point deducted. The acceptability of each excuse is solely at the discretion of the teacher.

If you are no longer attending class, it is your responsibility to drop the course. The instructor may drop a student after three consecutive unexcused absences; but is not required to do so. If the instructor does not drop you, and you do not drop, you will receive the grade of F.

Absence due to illness –

A student with an infectious disease (such as COVID-19, Strep, Flu, etc.) should not attend class. If a student is staying home due to illness, he/she should contact the teacher via phone or email. Every reasonable attempt will be made to help students who must miss class due to severe illness.

Face covering statement:

It is the policy of South Plains College for the Fall 2020 semester that as a condition of on-campus enrollment, all students are required to engage in safe behaviors to avoid the spread of COVID-19 in the SPC community. Such behaviors specifically include the requirement that all students properly wear CDC-compliant face coverings while in SPC buildings including in classrooms, labs, hallways, and restrooms. Assignment Policy -

All assignments are to be submitted for grading in the time period specified. Assignments missed due to absence may be excused, but late assignments will not be accepted.

Improper use of electronic devices during class may result in a "Technical" absence: In this case, the student may be marked absent for the day and/or asked to leave for the day.

Grading Policy/Procedure:

Average of four test scores (minus attendance penalties – see above) = 75% of Grade

Average of homework, classwork, and outside assignments (also as above) = 25% of Grade

Homework, classwork, and outside assignments are very important. Failure to submit these assignments due to absence may be excused by the instructor, but may or may not be accepted late.

Grades are assigned as follows: A = 90-100; B = 80-89; C = 70-79; D = 60-69; F = 0-59

The weight and valuation of test questions lies at the discretion of the instructor.

B. Special Requirements: This course is intended to be taken concurrently with **MUSC 1311, Commercial Music Sight Singing & Ear Training I**. Due to this “companion” course, students are expected to be familiar with some material covered in that course.
