Course Description: This is an introductory course that studies visual culture including arts through an exploration of ideas and processes, including evaluation of selected items, works, and creating individual projects. No prerequisite required. This course should **not** be taken by an art major or an art minor.

Online Course: This class is asynchronous. We will not meet online as a class at any specific time. That means you decide when to review materials, but you may also need to meet assignment deadlines weekly. Each week, I will post presentations, readings, viewings, audio, discussions, and all your assignments here in Blackboard.

This course is fully online and can be done at any time. Weekly participation and completion of week's module content is required with much flexibility as to whether you participate day or evening, or during the week or on the weekend. Whether you participate during the week or over the weekend is up to you, as long as you do not miss weekly content. Please login to Blackboard and participate a minimum of two times per week to fully complete all posted module content and check Blackboard content and assignments. You should expect to spend a minimum of 3-6 hours per week in this course, or the equivalent to the time spent in an on-campus ARTS 1301 course.

Course Objectives

• Cultivate a greater appreciation and understanding for visual culture, arts, its elements, practice. and theory.

- •Introduce students to a broad range of art media and techniques.
- Promote discussions of the visual, intellectual, social, and historical facets of visual culture and art.
- Provide techniques to evaluate, appreciate, and understand visual culture and art.

Course Content

- •Define the term "art" and its purposes, including general categories of visual arts.
- •Identify the visual elements and design principles.
- •Examine the techniques of the Fine and Applied Arts

•The art of the past historical and current trends and styles in visual arts and how the visual art produced has been influenced.

Possible Methods

- Online presentations
- •Articles, Videos, video write-ups
- Projects: writing, drawing, field observations, art process, and other creative endeavors

Course Requirements

• Participation: students are expected to participate in discussions (online), assignments, and field activities.

*If a student is continuously unresponsive in participation and to communication, a final warning email will be sent to that student and a week to respond to request. If no response is received at that point the student will be submitted to administration for course withdrawal.

•Textbook: There is **no** required textbook for this class. Readings and videos will be provided by the instructor. A base for some of the information covered in this class is in the textbook: *Gateways to Art: Understanding the Visual Arts,* it is recommended if you want a supplement to learning but not required.

Grading Criteria

•Class Participation: Input in-class activities and assignments as well as performance and work ethic including Class Civility.

•Class Civility: Information, images, and discussion topics may deal with subject matter uncomfortable or offensive to some students. Discussions require a calm and open-minded dialogue to consider different points of view. Civility and respect will be required at all times. There will be zero tolerance for inappropriate behavior.

-Individual behavior and attitude can greatly influence the class mood as a whole. Please conduct yourself in a way that promotes the productivity of the entire group.

•Academic Honesty: The faculty is strongly committed to upholding standards of academic integrity. These standards, at the minimum, require that students never present the work of others as their own.

Individuals who are exposed to someone with a known positive COVID-19 test are encouraged to either self-quarantine for the recommended time period identified by the CDC or wear a face covering for the same time period while in an SPC building. Neither of these will be required but are strongly encouraged. Faculty will be notified of any positive exposures in their class. They will accommodate the individual being quarantined as well as any other students who are self-quarantined due to exposure.

Recommendation for Testing – Here is some information that may be helpful to make a decision about getting tested:
Most people have mild illness and can recover at home without medical care. Contact your healthcare provider if your symptoms are getting worse or if you have questions about your health.

- Decisions about testing are made by state and local health departments or healthcare providers.
- If you have symptoms of COVID-19 and are not tested, it is important to stay home.

Anyone with a known exposure should wear a mask for 10 days and should seek a COVID-19 test on day five after exposure. If you test positive or develop symptoms, you should immediately self-isolate and seek a COVID-19 test.

Anyone who tests positive is required to self-isolate for five days. Following the five-day isolation period, if you are asymptomatic or your symptoms are resolving, you may return to work or class but should wear a mask for five additional days. If you are still symptomatic, please contact DeEtte Edens, Associate Director of Health and Wellness, prior to your return date.
