Course Syllabus:

- This syllabus, along with the course schedule, serves as your guide to all policies and requirements of this course. Course Description:

Sight Singing and Ear Training I is an introductory lab-based study and development of aural skills and sight singing in a diatonic framework through the study and application of solfège and systemized rhythm. The first semester will include the following components:

Aural identification of scales, intervals, and triads.

- Sight Singing
- Sight Reading Rhythms
- Rhythmic Dictation
- Melodic Dictation
- Error Detection

Note: You must be concurrently enrolled in Music Theory I. You must earn a minimum of a C in SSET I to advance to SSET II and also in Theory I to advance to Theory II.

Learning Outcomes:

Upon successful completion of this course, students will:

- Apply a method of sight singing to diatonic melodies in treble and bass clef, and oral demonstration of simple rhythms.
- Classify elements of music, such as scales, intervals and chords.
- Transcribe aural rhythms and diatonic melodies.
- Transcribe and analyze aural basic harmonic progressions.
- Read and reproduce rhythms in various simple meters.

Required Materials:

Textbook: <u>Ear Training & Sight-Singing: A Developmental Aural Skills Text</u> by Glen Ethier. Oxford University Press, 2013. ISBN 978-0-19-544617-3.

The textbook is <u>required</u> for all students. You will have great difficulty in this course without it. Always have your textbook in class. You will also be using the cd that comes with your textbook for assignments in this course.

Additional Requirements:

- Pencil with eraser
 - I will not accept anything in pen: you will automatically receive a zero.
- manuscript paper
- Metronome and Tuner (These can be apps)
- Keyboard app or access to a piano/keyboard
- Binder or folder to keep all your notes and assignments

Course Policies and Expectations:

- Class Preparation: You are expected to complete all assignments before class.
- Attendance Policy: Attendance is mandatory and will be taken at each class meeting. Missing class will directly affect your ability to succeed on exams and

assignments. You will only be allowed two (2) absences for this course. With your third absence, your grade will be lowered. Excessive absences are cause for you to be dropped from the course.

Inevitably, there will be instances in which you cannot attend class and can therefore be granted an excused absence under certain circumstances.

Examples of excused absences are:

- Severe illness which would require a doctor's care or hospitalization.
- Deaths in the family or other extreme family medical emergencies.
- Home disasters such as fires, burglaries, floods, etc.
- University-related functions, such as events with UTRGV ensembles.
- Military service or Religious observance.

All instances above will require documentation, such as corroboration from other faculty, doctor's notes, police reports, etc. Excused absences are at the discretion of the instructor.

Examples of <u>unexcused</u> absences include:

- Oversleeping or poor time management.
- Car trouble, transportation issues, or other failure to plan ahead.
- Work schedules, both on and off campus.
- Studying for or doing homework for other classes.
- Minor illnesses such as the common cold.
- Cold or inclement weather unless the university has decided to cancel class.
- Any other irresponsible or unprofessional decisions.

Tardiness Policy: Each class period starts promptly at 11:00 am. You will receive 5 attendance points for every class period. 1 point will be deducted for every 5 minutes you are late. If you are later than 11:25, it will be counted as unexcused absence. Failure to bring your textbook will be an automatic deduction of 3 attendance points.

Assessment:

Success in Aural Skills I will be based on homework, in-class participation, quizzes, projects and exams.

Exams:

Sight Singing

The sight singing exams will be given in my office during a scheduled date. You will be given an individual time during the class period.

Dictation

Dictation exams will take place during class on a scheduled date.

Final Exam

The Final Exam will be given according to the SPC Final Exam Schedule. **No Early administrations will be allowed.**

Exam Policies:

Absolutely no make-up exams will be given. In the event that you have an unavoidable scheduling conflict with an exam, it is your responsibility to bring it to the instructor's attention well ahead of time so that appropriate arrangements can be made. If a student should miss an exam for any reason, that exam grade will be recorded as a zero (0).

If the course schedule is adjusted at any point and exams are rescheduled, the instructor will announce it in class, on Blackboard and republish the course schedule online so that there is no confusion.

You are not allowed to leave the room during an exam. If you leave the room, you will not be allowed back in.

Assignments:

Assignments will be given on a regular basis, utilizing the CD that accompanies your textbook as well as the text itself and an App or Website of your choosing.

Assignments are due at the start of class on the due date. If they are not turned in by the time class begins (11:00 a.m.), it will be considered late and will automatically receive a 50%.

You are still responsible for submitting an assignment in the event of an excused absence. If there is any sign of cheating on exams or assignments, all parties involved will immediately receive an F.
