<b>TEXTBOOK</b>	<i>Architecture – Residential Drafting and Design</i> by Kicklighter, Goodheart-Wilcox Co., ISBN 978-1-63126-315-6
<b>DESCRIPTION</b>	This is a course in architectural drafting with emphasis on residential planning. The course presents basic principles, practices, procedures and symbols used in architectural drawing and includes the preparation of detailed working drawings for a residential structure with emphasis on light frame construction methods.
<b>SCOPE</b>	The scope of <u>Architectural Drafting - Residential</u> will be for sixteen weeks, which will include two (2) hours of lecture per week and four (4) hours of laboratory experience per week, for a total of ninety-six (96) contact hours per semester.
<b>COURSE OUTCOMES</b>	Utilize architectural terms, symbols, residential construction materials, and processes to produce a set of residential construction drawings including site plan, floor plan, elevations, wall sections, schedules, details, and foundation plan using reference materials.

<b>DAILY ASSIGNMENTS</b>	Practical drawing assignments and/or practical drawing tests will be completed during laboratory time. Practical drawing assignments will be graded on the following: <ol style="list-style-type: none"> <li>1. Neatness</li> <li>2. Line Criteria</li> <li>3. Text Criteria</li> <li>4. <b>REVIEW QUESTIONS</b>	Students will be assigned review questions for each topic covered in class, as well as from other readings assigned in Blackboard.
<b>PROJECTS</b>	Projects will be periodically assigned to demonstrate a practical proficiency in various topics covered in class. These projects are intensive and typically require multiple laboratory periods to complete.
<b>EXAMS</b>	Exams will be comprised of practical skills and objective material. Typically, there is one (1) midterm and one (1) final exam.

<b>ATTENDANCE</b>	<p><b>Three absences</b>, for any reason are allowed per semester. Tardies, defined as not being present in class within 5 minutes of the start of class, will count as ½ absence. Your grad will drop one letter grade per each absence over the allowable limit. Six absences will be grounds for the instructor to drop the student from the course.</p> <p>If a student has not participated in a course(s) in any form for a minimum of 3 weeks, without any communication from the student and is earning a solid “F”, an administrative withdrawal will be considered. The student will be contacted and encouraged to initiate a student withdrawal. After an additional week, faculty will initiate an administrative withdrawal.</p>
<b>WITHDRAWAL</b>	Any student wishing to drop this class should go through the proper procedure of initiating the withdrawal by obtaining a <b>drop form</b> from the Registrar's Office. This form must be signed by the instructor.
<b>COVID-19 POLICIES</b>	<p>When entering a classroom/lab, students must self-screen in accordance with COVID-19 posters. If a student is experiencing any symptoms listed, they must leave the campus.</p> <p>Students will clean/disinfect desk with wipes AFTER each use.</p>
