### GENERAL COURSE INFORMATION:

**Course Level:** Intermediate

**Course Description:** Presentation of the theory, practice, and chemistry of hair color. Topics include terminology, application, and workplace competencies related to hair color.

**End-Of-Course Outcomes:** Identify terminology, demonstrate hair color application, and practice workplace competencies related to hair color.

**Course Competencies:** Upon successful completion of this course, the student will:

- Possess knowledge of the color wheel.
- Exhibit an understanding of the terminology of hair color.
- Select appropriate product for a virgin tint to darken, virgin tint to lighten retouch, and a corrective color.
- Mix and apply properly the product for each of the previously listed processes.

- Select appropriate product for a virgin bleach, retouch, and a highlight service.
- Mix and apply properly the product needed for each of the processes stated in competency #5.
- Demonstrate and understanding and completion of all previous competencies.

### **Academic Integrity:**

Students who do not meet criteria for restricted enrollment will be counseled regarding their workplace competencies and career goals/objectives.

### **Attendance Policy:**

Punctual and regular attendance is required of all Cosmetology students. Unexcused tardiness and absences will not be tolerated. A doctor's note stating that it is safe to return to school in cases of contagious disease such as pink eye, strep throat or the flu is required. If more than 5% (7 hrs) of this course is missed student will have to attend make-up days. If student refuses to attend make-up days, then student may be at risk of being withdrawn due to excessive absences. Please refer to the SPC Cosmetology Handbook for more information.

### **Assignment Policy:**

All required work must be turned in on time. Assigned work is due on the day/class period assigned by instructor. Late work is generally not acceptable; however special consideration is subject to instructor discretion whether or not the work will be accepted.

### **Grading policy/ Procedure/Methods of Evaluation:**

See the General Catalog "Grades and Reports" for explanation of grades and grade point averages. The instructor will introduce the college policy and method to determine G.P.A. during the course of instruction. The Texas Department of Licensing and Regulation requires an overall minimum grade of 70. Therefore this course requires the same. An overall grade below 70 is considered an F.

- Understanding, demonstrating and explaining terminology related to hair color and chemistry.

- Understanding and using successfully the color wheel as related to hair color.
