GENERAL COURSE INFORMATION:

<u>Course Description</u>: An introduction to the basic principles of regulators, reclosers, and capacitors. Topics will include the internal construction of each device, installation techniques, principles of operation, troubleshooting techniques, and the safe restoration of service to such devices.

<u>Course Learning Outcomes</u>: The goals/objectives of this course are: Regulator, recloser and capacitor functions; internal construction; basic operating principles.
