Course Description: This course is a study of the functions performed in the American system of state governments, with special reference to the development of governance in Texas and its Constitutions. This course satisfies the Legislative requirement for teacher certification.

Course Purpose: Government 2306, as taught at South Plains College, is a reading intensive course designed to acquaint the learner with the origin and development of the Texas Constitution, structure and powers of state and local government, federalism and intergovernmental relations, political participation, the election process, public policy, and the political culture of Texas. This course meets the statutory requirements as set forth by the State of Texas.

Student Learning Outcomes:

Students who have complete this course will:

1. Explain the origin and development of the Texas Constitution
2. Demonstrate an understanding of state and local political systems and their relationship with the federal government
3. Describe separation of powers and checks and balances in both theory and practice in Texas
4. Demonstrate knowledge of the legislative, executive, and judicial branches of Texas Government
5. Evaluate the role of public opinion, interest groups and political parties in Texas
6. Analyze state and local elections processes

7. Describe the rights and responsibilities of citizens
8. Analyze issues, policies and political culture in Texas

Students will be expected to perform satisfactorily in four FCA.

 - a. Demonstrating intercultural competence,
 - b. Identifying civic responsibility,
 - c. Engaging in regional, national, and global communities.
4. Personal Responsibility – to include the ability to connect choices, action, and consequences to ethical decision-making by:
 - a. Reading, understanding and affirming agreement and acceptance of principles, guidelines and requirements set forth in the “Statement of Personal Responsibility of Students” (Attached)
 - b. Evaluating choices and actions and relating consequences to personal decision-making
 - c. Accepting personal responsibility for decisions and actions taken or not taken

Exams: There will be three exams in this course. Exams will consist of multiple choice questions and possibly a few true/false or short answer questions.

Exam 1 will cover the material from Week 1 through Week 3

Exam 2 will cover the material from Week 5 through Week 8

Final Exam will cover the material from Week 10 through Week 14

Quizzes: Each week (except exam weeks) you will complete a quiz on the relevant topic. Reading the textbook, lecture slides and other course material on the topic of the week is sufficient to successfully complete each quiz.

Essays: On three occasions you will be asked to write an essay to address a question pertaining to the subject of the week. Your essay will be a written assignment pertaining the topic of the week. You will attach a PDF file to submit this assignment

Discussion Posts: On three occasions you will be asked to participate in a discussion forum. I will assign a topic for discussion and you must (1) submit a discussion post addressing the question posed to the Discussion Forum and (2) you must respond to the discussion post of at least one other student. You will be graded on completion of each task as well as your use of the course material.

Plagiarism and Cheating: Plagiarism and cheating in any form will not be tolerated in this course. South Plains College policies allow a wide range of punishment for cheating including failing the assignment, quiz, exam or the course. I will be vigilant against cheating and plagiarism in any form. At a minimum you will receive a zero for the assessment if you cheat or plagiarize.

Late Work: Late work will not be accepted and there will be no opportunities to make up exams, quizzes, or other assignments after their due date. Since this is an online course you have the flexibility to complete assignments at any time throughout the week (or earlier) before the assessment's due date. Please be conscious of due dates so that you can receive credit for every assessment.

Extra Credit: Extra credit will likely not be given in this course. If necessary, I will provide extra credit opportunities to the entire class.
