Course Title: Statistical Methods and Support Course

Course Description: Math0342 is to be taken concurrently with MATH 1342. Background topics which are necessary for a student to successfully complete MATH 1342 will be covered, with an emphasis on integers, percentages, graphing, fractions, and exponents.

Prerequisite: Maximum score of 349 on the TSIA without an ABE score, or a successful completion of NCBM 0105..

Textbook and Supplies:

- **REQUIRED:** Any scientific Calculator, notebook paper and a spiral.
- Math 1342 Elementary Statistics Workbook by Pat Foard

Zoom app on cellphone or laptop as we will be meeting for virtual office hours and physical office hours. If the class is forced completely online we will also use Zoom for testing puposes.

Core Curriculum Objectives addressed:

- **Communications skills**—to include effective written, oral and visual communication
- **Critical thinking skills**—to include creative thinking, innovation, inquiry, and analysis, evaluation and synthesis of information
- **Empirical and quantitative competency skills**—to manipulate and analyze numerical data or observable facts resulting in informed conclusions

Student Learning Outcomes: Upon completion of this course and receiving a passing grade, the student will be able to:

1. Explain the use of data collection and statistics as tools to reach reasonable conclusions.
2. Recognize, examine and interpret the basic principles of describing and presenting data.
3. Compute and interpret empirical and theoretical probabilities using the rules of probabilities and combinatorics.
4. Explain the role of probability in statistics.

5. Examine, analyze and compare various sampling distributions for both discrete and continuous random variables.
6. Describe and compute confidence intervals.
7. Solve linear regression and correlation problems.
8. Perform hypothesis testing using statistical methods.

Student Learning Outcomes Assessment: A pre- and post-test questions will be used to determine the extent of improvement that the students have gained during the semester

Course Evaluation: Attendance of all class meetings is mandatory. In order to be officially dropped from the class, students must go to the registrar's office to withdraw with a grade of W. Students who fail to withdraw themselves from a class will receive an F for the course.

Cell Phones: In this class, the instructor reserves the right to ask a students to leave the class if a cell phone is left on and it disrupts the class. Homework: Homework will be assigned daily. Questions are taken at the next class period only. You are responsible for keeping up to date and prepared. No late homework will be accepted...no exceptions. Keeping up to date and current on homework has been shown to correlate with passing the course. Some short homework assignments will be done in class and turned in during the class. These in class assignments cannot be made up.

*During exams and quizzes the use or possession of smartphones, smart watches, water bottles or any labeled bottled drinks, and bathroom breaks are not allowed. Any infraction will be penalized with a minimum 15 point deduction on exam and can result in the removal of the student from the course.

There will be departmental final project given by all instructors.

The student will be allowed to miss twenty percent (20%) of class assignments for the semester, **for any reason**.
