Course Description: Origin and development of the U.S. Constitution, structure and powers of the national government including the legislative, executive, and judicial branches, federalism, political participation, the national election process, public policy, civil liberties and civil rights.

Course Objectives addressed:

- 1. **critical thinking:** to include creative thinking, innovation, inquiry, and analysis, evaluation, and synthesis of information.
- 2. **communication:** to include effective development, interpretation and expression of ideas through written, oral and visual communication.
- 3. **social responsibility:** to include intercultural competence, knowledge of civic responsibility, and the ability to engage effectively in regional, national, and global communities.
- 4. **personal responsibility:** to include the ability to connect choices, actions, and consequences to ethical decision-making.

Student Learning Outcomes (SLO):

Students who have completed this course will:

- 1. Explain the origin and development of constitutional democracy in the United States.
- 2. Demonstrate knowledge of our federal system.
- 3. Describe separation of powers and checks and balances in both theory and practice.

- 4. Demonstrate knowledge of the legislative, executive, and judicial branches of the federal government.
- 5. Evaluate the role of public opinion, interest groups, and political parties.
- 6. Analyze the election process.
- 7. Describe the rights and responsibilities of citizens.
- 8. Analyze issues and policies in U.S. Politics.

Student Learning Outcomes Assessment: A writing assignment rubric will be used to determine the extent of improvement that the students have gained during the semester.

Quizzes: The instructor will administer quizzes over materials. Should a student miss a chapter reading quiz deadline they will not be allowed to make-up the quiz without instructor approval. You will be allowed up to **TWO** attempts for each quiz for the **average grade** of your attempts (you do not have to take quizzes twice, but this will prevent those from trying to "preview" questions rather than properly preparing by reading).

Exams: Each week you will have an exam for a total of 3 exams including the final. Reviews will be provided so that you can prepare for each exam. The final exam will be multiple choice and fill-in-the blanks for ease of grading because grades are due shortly after the scheduled exam date.

Assignments: There will be a reasonable number of assignments in this class (not all will require the same amount of effort). These assignments are designed to expand student understanding and knowledge. Remember that individual assignments will have a greater impact on your grade than missing a single quiz. It would always be best to complete all assignments rather than attempt to offset a zero in these categories of evaluation. Please be advised that grading time varies with the type of assignment. Email me if you have concerns with the speed of feedback. This class is 19 days long so there is not a lot of room for late work. Please let me know if you have any issues with the pacing or due dates so I can help you succeed.

AI (artificial intelligence): If I suspect that a student has submitted artificially generated discussions, assignments, or test answers, you will receive a zero for your work, AI detection evidence, and a notice requesting a conference. You will be required to meet with me via video conference. If you fail to set up a meeting, your grade will remain a zero. You will be given the opportunity to verbally respond to questions. If you can explain your answers, I will update your grade. While AI is useful, it is silly to attend a class where you have no intention of learning.

Tentative Course Schedule for Pacing

This course takes place across 3 weeks. I will separate your course content into those 3 weeks to help you stay organized. You may jump ahead on video assignments and quizzes, but exams will have a scheduled window.
